Recruitment on Deputation at GIMS, Greater Noida

- 1- The maximum age limit for the appointment on deputation basis shall be 50 as on the closing date of receipt of applications.
- 2- Supporting documents related to qualification, experience etc. has to be self-attested.
- 3- The pay and the other terms and conditions of the appointed candidate will be as per Govt. of U.P. as amended from time to time.
- 4- The application of the willing candidates may be forwarded in the proforma given at Annexure II, alongwith attested ACRs/APARs, vigilance clearance, integrity certificate and a statement showing details of major / minor penalties imposed on them, if any, during the period of last 03 years, through proper channel. Bio-data of only those candidates, whose services can be spared within 1month on their selection, may be forwarded.
- 5- If the applicant feels that the application through proper channel will get delayed, the applicant should send an advance copy of his/her application within the prescribed time limit. The advance copy of the application shall be considered in the processing stage. However, in case the application along with the requisite documents is not received within 3 weeks after the last date for applications, it will be presumed that the parent organization is not in favour of appointment of the applicant on deputation.
- 6- The competent authority reserves the right to cancel or withdraw the vacancy without assigning any reason.
- 7- The applicant should not have been convicted by any court of law.
- 8- The application should be forwarded in an envelope mentioning the post applied for and may be sent to the Director, Government Institute of Medical Sciences, Greater Noida, Gautam Buddha Nagar (U.P.) 201310 latest by 23rd March, 2024.**
- 9- Application received after expiry of the prescribed period and/or found to be incomplete in any manner and/or not accompanying all the requisite documents will not be entertained.

Note 1:

The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, the deputationists shall not be eligible for consideration for appointment by promotion.

Note 2:

Period of deputation including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not exceed three years. The Maximum age limit for appointment by deputation shall be 'Not exceeding 50 years' as on the closing date of receipt of applications.

Note:

The initial period of deputation for the above posts shall ordinarily be 3 years from the date of appointment & further extendable as per the orders of Govt. of U.P. Other Terms and Conditions of deputation will be governed by the orders/amendment orders issued by the state Govt. from time to time.
