- 5. Separate application should be submitted for each position. Allotment of project to the successful candidate will be decided by the competent authority at its discretion.
- 6. No TA/ DA will be paid to attend the interview / personal discussion and candidates have to arrange transport/ accommodation themselves.
- 7. The persons engaged in Project Positions shall not have any claim on a regular post in GIMS or in any of its institutes or in any other government organizations and their project term with breaks or without breaks in any or multiple projects will not confer any right for further assignment or transfer to any other project or appointment / absorption/ regularization of service in funding agency or in CST UP or GIMS, Greater Noida.
- 8. Candidate must bring his/ her duly filled in application form in the prescribed format with a recent passport size colour photograph along with a detailed bio-data / CV and all relevant documents; duly self- attested; in proof of his/ her educational qualifications [all certificates and mark sheets from 10th standard onwards], working experience, age caste and photo id [Aadhar card/ Indian passport/ PAN card/ Driving License] etc.

Successful candidates will normally be engaged on Project Human Resource Positions initially for a period of one year or less, depending upon the tenure of the project and functional requirements.
