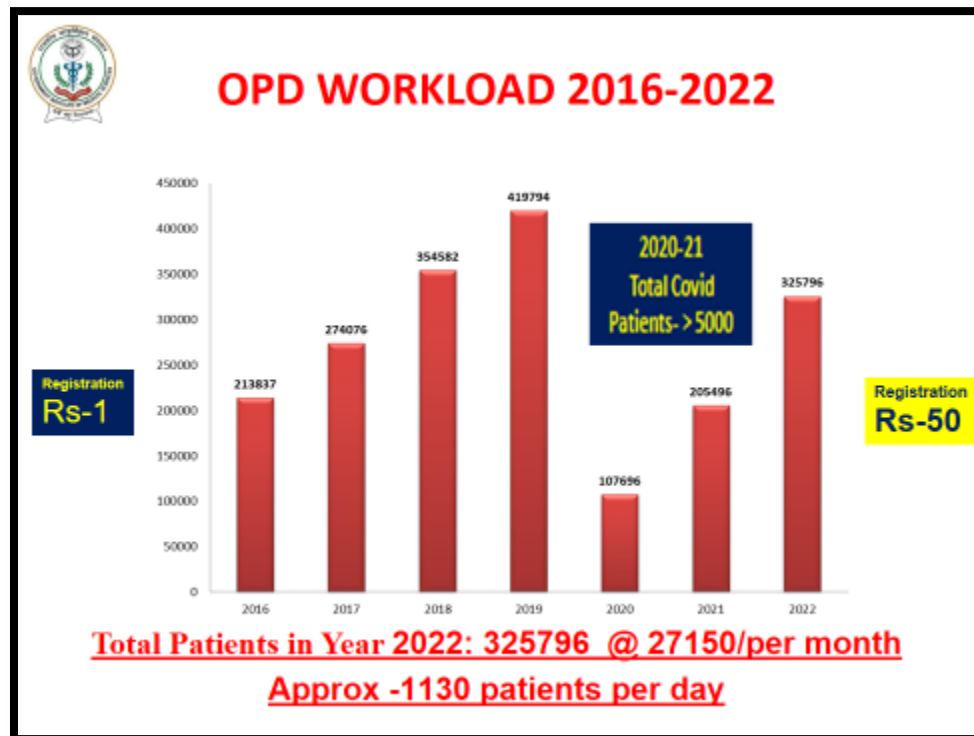

of Medicare in the region and the institute need to develop in to a large multispecialty hospital. The Workload of patients over last 5 years is as follows:-



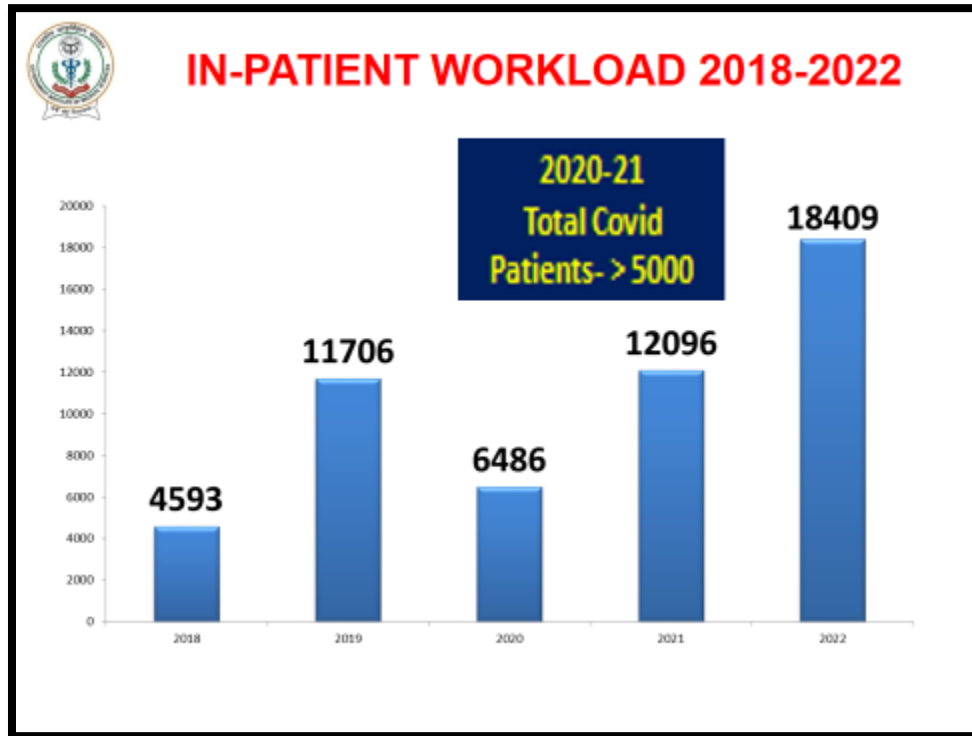

began as a small outpatient care with 30-40 patients per month now accommodates over 100 patients per month.

8. GIMS hospital is 630 bedded with all broad specialities. There are approximately 1500-2000 patients are visiting every day and more than 450 patients are admitted in the hospital. The total no of patients reported in 2022 are approx. 3, 25,796 and 18409 patients
9. GIMS has existing infrastructure to establish cardiac centre for patient care in the institute as with a view to provide proper treatment facilities to the patients coming to the institute.
10. Equipments and tests rate from equipments must be at highly subsidized rates on the lines of SGPGIMS or KGMU Lucknow to serve the poor and needy patients as a welfare measure for patients attending GIMS, Greater Noida.

SCOPE of services:-

11. Important scopes of services for the Cardiac center will include-
 - Cardiology OPD services
 - Non invasive cardiac services like ECG, 2D Echo, TEE, TMT, Stress Echo EPS study and Holter monitoring.
 - Invasive labs for Angiography (coronary/peripheral), Angioplasty (coronary/peripheral), Pacemaker (temporary/permanent), AICD, CRT-D/P, Cath study for Congenital heart disease, Valvuloplasty for Mitral/pulmonary/aortic stenosis and Device closure for ASD,PDA,VSD,RSOV.
 - Along with cardiac cath lab we are planning to establish thrombolysis Unit and extend other
 - Cardiac Cath Lab along with cardiac coronary unit (CCU)

(Services will be started in phased manner)

12. GIMS will provide infrastructure space for cardiac cath lab, CCU and Non Invasive cardiac instruments. Present ICU can be upgraded to CCU if feasible.
13. All the equipments/machinery for cath lab, CCU and Non invasive test will be provided by participating company.
14. Manpower like Cardiologist, cardiac technician and nursing staff for cath lab, CCU and non invasive lab will be provided by the participating company. GIMS will provide the nodal officer for the supervision and quality control.
15. All the drugs, consumables and disposables are to be provided by the participating company.
16. All the invasive and non invasive cardiac procedure charges will be as per latest rate of SGPGI, Lucknow.

1. ELIGIBILITY CRITERIA

Agency should have:-

1. Minimum experience of five years in the field of high end related equipment operations.
2. Should have all the valid registration documents for compliance to all statutory requirements i.e. registration with appropriate authority

2. GENERAL TERMS AND CONDITIONS

1. Applications should be submitted in the prescribed form only. Eligible and competent agencies will be short- listed for the empanelment.
2. Empanelment of agency will be done on the basis of criteria enumerated in these documents along with professional competence.
3. The agencies will be responsible to provide all diagnostic and therapeutic services related to cardiac centre.
4. The selected agency will provide services at the point of care.
5. The cost of tests from the patients to be deposited on the cash collection counter of GIMS. The service provider will provide the monthly bill to the institute based on number of procedures/tests performed on the machines. The institute will make payment within 07 days to the service provider.
6. The agency applying for empanelment should furnish all the particulars related to its status and functioning.
7. The date of declaration of qualified/empanelled agency will be at the discretion of GIMS.
8. All the pages of the EOI are to be self attested.
