There are more than 1500 patients are visiting every day and more than 450 patients admitted in the hospital. The total no of patients reported in 2024 were 383467 OPDs and 27047 patients were admitted.
14. The agency will enquire patients planning to take treatment/ surgery or admitted at GIMS regarding empanelled insurance companies, cashless schemes, and eligibility criteria.
15. The agency will guide patients and their families regarding documentation requirements and pre-authorization process and coordination with the hospital's admission desk to identify insured patients early in the admission process.
16. Agency will liaison with the treating department for preparation and liaison with TPAs for submission of pre-authorization requests and get approval.
17. Agency will maintain a dedicated helpdesk within the hospital premises, operational during all working hours.
18. Agency will prepare detailed claim documents and other supporting documents.
19. Agency will follow up with insurers for approval, partial settlement, or rejection clarification
