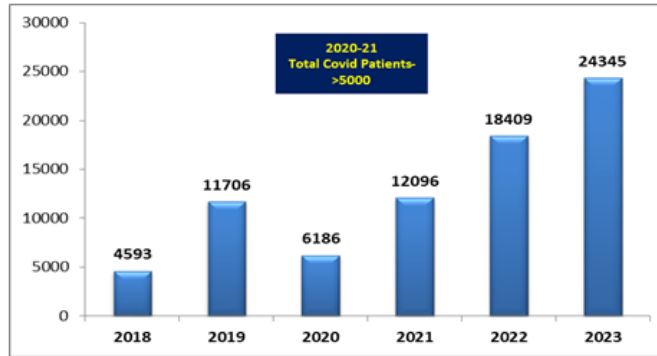

Institute needs to develop in to a large multispecialty hospital. The Workload of patients over last 5 years is as follows:-



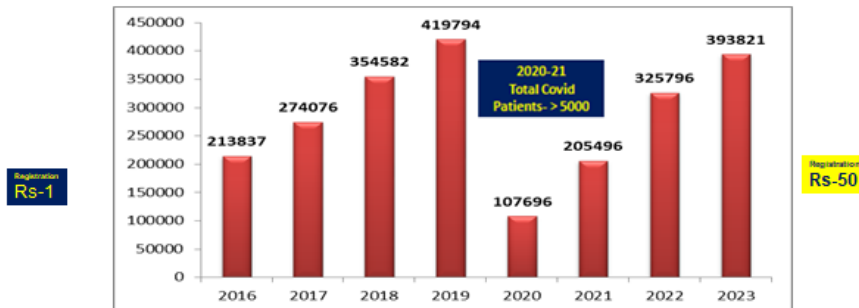
## IN-PATIENT WORKLOAD 2018-2023

2. GIMS has existing infrastructure to establish cardiac center. The institute is located in Greater Noida at the gateway of western U.P. near the interjunction of Yamuna Expressway and Eastern peripheral expressway. The patients are coming from western UP, UT, Haryana and Delhi NCR.
3. GIMS is running OPD services of Cardiology bi-weekly for last one year and more than 1000 patients have been provided the consultancy so far. What began as a small outpatient care with 30-40 patients per month now accommodates 100-120 patients per month.
4. GIMS is inviting EOI to hire diagnostic & therapeutic service. Cardiac relevant equipment for diagnosis like cardiograph, angiograph and other. All the consumables, secretarial assistance will be provided by the GIMS. Technicians will provide only technical support to carryout tests and also ensure the maintenance of these equipment.
5. GIMS is proposing this cardiology services, with a view to provide the comprehensive medicare under one roof at most cost effective rates to the poor and needy patients as a welfare measure for patients attending GIMS, Greater Noida.

## 6. SCOPE OF WORK

### a. GIMS Greater Noida

- i. Infrastructure space will be provided in present condition by GIMS
- ii. Equipments – available beds, cardiac table, bedside lockers
- iii. Oxygen supply
- iv. Other available equipment's
- v. ICUs will be made available as per institute policy
- vi. Electricity and water supply
- vii. Generator supply
- viii. Private wards as per hospital policy
- ix. All the investigations, CT/MRI and HRF services for drugs and consumables will be made available for the cardiology center as per institute policy.

### b. The Service provider Agency

- i. Will provide all Cardiology services from OPD services, Emergency services, non-invasive to invasive cardiac procedures in a progressive manner.
- ii. The agency will furnish available space with necessary equipments for Cath Lab, observation beds and OPD services.

- iii. All the equipments and manpower including doctors, nurses and Technicians for Invasive & Non-Invasive cardiology required for cardiac centre setup will be provided by the agency
- iv. Will provide training to Doctors, Residents, Nurses and Paramedical staff of the institute while the later will assist in the functioning of the center.
- v. Agency will display all the rates of investigations and treatment
- vi. There will be 10% of all the OPD/IPD/Investigations, procedure and treatment for the poor/ destitute/hospital staff and students will be made free on the recommendation of Director/person nominated by the director.
- vii. The charges from the blood relatives of the hospital staff will be done as per the Govt schemes.
- viii. Will ensure all ethical considerations as per law

## 7. Financial Implications-

- a. The agency will provide specific details regarding patients covered under the Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (ABPMJAY), Ex-Servicemen Contributory Health Scheme (ECHS) and BPL patients will provide processing fees in terms of fix percentage of Govt charges to the institute.
- b. For patients, other than Govt schemes, like private Insurances, private coming for treatment not covered under the aforementioned schemes, the agency will provide services at lower rates than the prevailing rates in the city and provide offer higher percentage of processing charges to the institute.
- c. The cost of tests / treatments to be deposited on the cash collection counter of GIMS. The service provider will provide the monthly bill to the institute based on number of procedures/tests performed on the machines. The institute will make payment within 07 days to the service provider.
- d. All transaction will be through the GIMS cash counter. Digital transactions will be preferred as far as possible.
- e. The payment to the agency will be provided within 7 working days to the agency after deducting the GIMS processing charges.

## 8. GIMS reserves right

- a) To take final decision regarding empanelment or to modify or scrap the process,
- b) To accept or reject the request of any agency for empanelment, and
- c) To keep or remove any agency on the panel approved for outsourcing trained technician

- b. Should have all the valid registration documents for compliance to all statutory requirements i.e. registration with appropriate authority

## 10. GENERAL TERMS AND CONDITIONS

1. Applications should be submitted in the prescribed form only. Eligible and competent agencies will be short- listed for the empanelment.
2. Empanelment of agency will be done on the basis of criteria enumerated in these documents along with professional competence.
3. The agencies will be responsible to provide all diagnostic and therapeutic services related to Cardiac Centre.
4. The selected agency will provide services at the point of care.
5. The agency applying for empanelment should furnish all the particulars related to its status and functioning.
6. The date of declaration of qualified/empanelled agency will be at the discretion of GIMS.
7. All the pages of the EOI are to be self attested.
8. The bidder has to furnish an undertaking that the organization has not been blacklisted in the past by any Government Departments /Boards/ Corporations or reputed Private Companies.
9. GIMS reserves the right to accept or reject any or all the EOIs without assigning any reasons thereof.
10. GIMS shall have the right to delete any agency from the panel during the currency of the period of the empanelment, without assigning any reason thereof.
