INTRODUCTION

7. PROPOSAL

12. GIMS is proposing to Empanelment for Setting up and Operation of EV Charging Station at predefined location of GIMS Hospital premises.

SCOPE OF WORK

13. GIMS will grant Charging point Operator (CPO) and Commercial Service Operator (CSO) agency to use the Site for setting up and operating an EVCS.
14. Agency will be responsible for installing atleast 04 charging points of Fast Charging EVCS.
15. Agency will be responsible for Design, install, and commission the EVCS at its own cost.
16. Agency will be responsible to obtains all necessary approvals, permits, and consents from statutory authorities.
17. Agency will be responsible to maintain and operate the Charging Station in accordance with applicable laws and standards.
18. Agency will be responsible to ensure minimum disturbance to other occupants (if any) and maintain cleanliness and safety at the Site.
19. For the installation and operation of Electric Vehicle (EV) Charging Stations within the license area, the selected Charge Point Operator (CPO) shall be mandatorily associated with the Distribution Company (DISCOM) holding the electricity distribution license for the respective jurisdiction in which the charging station is proposed to be established. The CPO shall obtain all necessary technical approvals, permissions, and clearances from the DISCOM prior to commencement of installation and operations.
20. GIMS shall provide the requisite land or space necessary for setting up the EV Charging Point.
21. GIMS shall extend local support as may be required, including assistance in obtaining relevant permissions and approvals from local authorities or stakeholders.
22. GIMS will ensure uninterrupted and exclusive access to the identified site for setting up and operating the EVCS.
23. GIMS will cooperate in ensuring the safety and security of installed EVCS infrastructure.
24. GIMS will allow installation of surveillance systems and other security measures on-site.
25. GIMS will permit the installation of branding, signage, and promotional material at mutually agreed locations on the property to enhance station visibility.
26. GIMS will allow regular maintenance, inspection, and service visits by the EVCS operator or its representatives.

FINANCIAL IMPLICATIONS-

27. The agency shall provide the tariff rates for EV users for electricity consumption on a per-unit basis and propose the percentage of revenue sharing with GIMS on the same basis.
28. All user payments for charging services shall, preferably, be processed through the CPO's own secure digital payment system, integrated with appropriate billing and transaction tracking mechanisms. The

CPO shall ensure that the payment system is compliant with applicable statutory requirements, provides transparent transaction records, and facilitates easy reconciliation for all stakeholders.

29. No rent shall be payable by agency to GIMS for establishing EVCS in the premises.

GIMS RESERVES RIGHT

30. To take final decision regarding empanelment or to modify the terms and conditions
31. To accept or reject the request of any agency for empanelment, and
32. To keep or remove any agency on the panel approved for outsourcing
33. To keep or remove any staff of the service provider involved in any unlawful activities.

ELIGIBILITY CRITERIA

Agency should have:-

34. Applications should be submitted in the prescribed form only. Eligible and competent agencies will be short-listed for the empanelment.
35. The Applicant should have at least three years of experience in providing services to Government/Semi Government/Autonomous Body.
36. The Applicant should be registered with the authority concerned of the State or Central Government,
37. The Applicant should submit the copy of income tax, PAN, GST certificate with valid registration Number.
38. The financial turnover of the agency should be approximately ₹1 crore per year.
39. The agency should have installed a minimum of 50 DC chargers.
40. The Applicant should have their office set up in the 50 KM radius from the GIMS Institute.
41. The Applicant should not have been blacklisted by any Central/State Government/PSU.

GENERAL TERMS AND CONDITIONS

42. Applications should be submitted in the prescribed form only. Eligible and competent agencies will be short-listed for the empanelment.
43. Registered legal entity in India.
44. Experience in setting up and operating EV charging stations or similar infrastructure.
45. Financial capacity to invest in installation and operation.
46. Necessary licenses/approvals from concerned authorities.
47. Proven track record in relevant projects (proof to be enclosed)
48. Empanelment of agency will be done on the basis of criteria enumerated in these documents along with professional competence.
49. The date of declaration of qualified/empanelled agency will be at the discretion of GIMS.
50. All the pages of the EOI are to be self-attested.
51. The bidder has to furnish an undertaking that the organization has not been blacklisted in the past by any Government Departments /Boards/ Corporations or reputed Private Companies.
52. GIMS reserves the right to accept or reject any or all the EOIs without assigning any reasons thereof.
53. GIMS shall have the right to delete any agency from the panel during the currency of the period of the empanelment, without assigning any reason thereof.
