EXPRESSION OF INTEREST FOR OPERATING JUICE SHOP AT GIMS GREATER NOIDA

- a) Government Institute of Medical Sciences, Greater Noida, is an autonomous tertiary care institute of Government of UP, with a mission to provide affordable health services to all sections of the society and has been envisioned to be in the forefront of providing excellent professional medical education and multi-disciplinary research. This Institute has a fully functional 500 bedded hospital with average OPD load of 1500-2000 patients per day and average IPD load of 250-300 beds per day. The institute got the Letter of Permission (LOP) from Medical Council of India and started MBBS course for 100 students since the academic year 2019-20. Presently 400 MBBS students are undergoing training at GIMS. In addition to above, it has got its own Nursing & Paramedical College. The institute has also started post graduate courses (DNB) in Medicine, Obs & Gynae, Pediatrics and Anesthesia, through National Board of Examinations.
- b) The vendor will pay a nominal rent of _____ (+ GST as applicable) /- per months for utilizing the premises of GIMS, Greater Noida.
